Press Release KIOCL BOUNCE BACK IN PRODUCTION DURING 2016-17

KIOCL Limited, a Central Public Sector Undertaking under Ministry of Steel, which is pioneer in iron ore beneficiation and pelletization in the Country has bounced back in its production target during the fiscal year 2016-17 surpassing the Very Good target set by the Ministry with a production of 14.60 lakh tons of pellets as compared to the last two fiscal years and in particular to the last year which was 1.0 lakh ton only.
