**Sub: Revision of scales of pay of Board level/
Below Board level Executives & Non-unionized
Supervisors w.e.f.01.01.2007**

In pursuance of the 'Presidential directives' conveyed by the Govt. of India, Ministry of Steel vide their letter No. 5(21)/2008-KDH dated 02.12.2009 the Management is pleased to announce the revision of salary structure of Board Level/Below Board Level Executives and Non-unionized Supervisors.

1.0 REVISED SCALES OF PAY:

The existing and the corresponding revised scales of pay effective from 01.01.2007 are as given below:

- a) The existing structure of grades and entitlements in case of Executives/Non-unionized Supervisors shall remain same, wherever there is a sharing of pay scale.
- b) Applications for Board level posts in Schedule 'A' CPSEs will be forwarded to the PESB in respect of Executives in E8 (GM) and above grades only.



2.0 FIXATION OF PAY IN THE REVISED SCALE OF PAY:

a) Basic pay + stagnation increments as on 1.1.2007

+

b) Dearness Allowance at 78.2% on (a) above.

+

c) Fitment benefit at the rate of 30% of (a) and (b) above.

The aggregate amount arrived would be rounded off to the next ten rupees and would be the revised basic pay as on 1.1.2007. If the amount arrived is less than the minimum of the revised pay scale, basic pay shall be fixed at the minimum of the revised pay scale.

2.1 Where Executives/Non-unionized Supervisors drawing pay at two or more consecutive stages in an existing scale get bunched, then for every two stages so bunched, benefit of one increment shall be given to the executive drawing higher pay in the pre-revised structure. However, this will be taken up separately and will be resolved by a Committee.

2.2. If any extra ordinary increment(s) and /or increase in the pay in respect of Executives/Supervisors have been granted with retrospective effect, which affects the revision of pay as on 01.01.2007, such increment and/or increase in pay will be ignored for the purpose of fitment/pay revision.

The Fitment tables are given in Annexure .

3.0 Increment: The rate of annual increment will be at the rate of 3% of the revised basic pay. The fraction of a rupee, if any, in the basic pay would be rounded off to the next multiple of ten. The existing increment date applicable to the Executives/Non-unionized Supervisors shall not change as a consequence of fitment in the revised scales.

3.1 Stagnation Increment: Executives/Non-unionized Supervisors would be allowed upto a maximum of three stagnation increments, one after every two years, upon reaching the maximum of the revised scales of pay provided the Executive/ Non-unionized Supervisors is rated "Good or above".

3.2 Fixation in respect of Executives appointed on or after 01.01.2007:

a) Basic pay of Executives/GETs/ETs appointed/absorbed in KIOCL Pay scales after 1.1.2007 who were allowed basic pay at the minimum in the pre-revised scale of pay shall be fixed at the minimum of the corresponding revised scales of pay.

b) In cases where pay fixation had been done in the pre-revised scale taking into account the Basic pay last drawn in the previous Organization(PSU/Govt. Organizations only), pay protection would be granted in the revised scale also, based on the revised last pay drawn (basic + DA) in the previous Organization, provided the scales of pay in the previous organization have also been revised and a revised last Pay Certificate is produced. In the absence of such a revision in the previous organization, the pay shall be fixed at the minimum of the concerned revised scale of pay.



c) Employees promoted after 1.1.2007 from Non-Executive grade to the Supervisory grade shall draw provisionally the minimum revised basic pay in the relevant supervisory grade pending revision of pay structure of employees in Non-Executive category, subject to the following conditions:

i) In case the sum of revised basic pay & dearness allowance on the date of promotion is less than the sum of pre-revised basic pay, dearness pay, dearness allowance, then the difference of the same shall be allowed as personal pay, which shall be considered for all payments linked to basic pay.

ii) On revision of pay structure of applicable Non-Executive category, personal pay so granted shall be adjusted/recovered against arrears payable.

3.3 Pay fixation on promotion: The pay of Executives/Non-unionized Supervisors promoted to higher Scale of pay/post on or after 01.01.2007 would be fixed in the revised scale by adding one notional increment equal to the increment being drawn by the Executive/Non-unionized Supervisor in the pay scale, before such promotion and pay fixed in the promoted pay scale and rounded off to the next multiple of Rs.10/-.

4.0 Dearness Allowance: 100% DA neutralization will be adopted for all the Executives/Non-unionized Supervisors who are on IDA pattern of scales of pay, w.e.f. 01.01.2007. Thus DA as on 01.01.2007 will become zero with link point of All India Consumer Price Index(AICPPI) 2001 = 100, which is 126.33 as on 01.01.2007. The periodicity of adjustment will be once in three months, as per the existing practice for these categories. The quarterly DA payable from 01.01.2007 will be as per new DA scheme as given below:

5.0 House Rent Allowance: The House Rent Allowance will be at the following rates as per Govt. directives:

Cities with population	Rates of HRA
50 lakhs & above Classified as "X"	30% of basic pay
5 to 50 lakhs Classified as "Y"	20% of basic pay
Less than 5 lakhs Classified as "Z"	10% of basic pay

5.1. In accordance with the revised guidelines, the House rent at Bangalore, New Delhi and Chennai is payable at 30 % of Basic Pay and at Mangalore Bhubaneswar, Visakhapatnam at 20% and all other locations, at 10 % of basic pay.

5.2 With effect from 02.12.2009, HRA shall be granted as per the revised classification of cities/ towns by the Central Government on revised basic pay.

6.0 **City Compensatory Allowance:** In pursuance of Presidential Directives the CCA stands abolished w.e.f. 02.12.2009.

7.0 **Family Planning Incentive:** Executives/Non-unionized Supervisors who are in receipt of family planning incentive prior to 01.01.2007 would be allowed to draw the increment equivalent to the lowest rate of increment applicable to the relevant revised scales of pay corresponding to the pay scale of the post against which the employee concerned was initially granted the increment as personal pay, with effect from 01.01.2007. Executives/Non-unionized Supervisors who have drawn such increment on or after 01.01.2007 would be allowed the increment based on the increment rate (3%) in the revised scale of pay from the date of drawal of such increment.

8.0 **Non-practicing allowance:**

Non-practicing allowance (NPA) to doctors w.e.f. 02.12.2009 shall be as under:

The above NPA shall not be counted for any other purpose like DA, PF, Gratuity, Leave encashment, etc.

9.0 **Gratuity:** The ceiling of Gratuity payable is raised to Rs. 10 lakhs w.e.f. 01.01.2007. Gratuity / differential gratuity shall be calculated and paid on the basis of the revised basic pay and DA, subject to applicable terms and conditions, income tax rules etc.

10.0 **Superannuation benefits:** Superannuation benefits shall be paid at the rate of 30% of the revised basic pay & DA. This shall include contributory provident fund, gratuity, pension & post-superannuation medical benefits (scheme to be formulated in due course).

11.0 Differential amount of leave encashment on account of pay revision effective from 01.01.2007 will be paid.

11.1 With effect from 1.1.2007 contribution to the provident fund shall be recovered on the basis of revised pay.

12.0 **Adjustment of Advance Adhoc Payment:** The Adhoc amount paid vide Personnel Circular No.38/2008 dated 29.04.2008 would be adjusted against the benefits arising out of this wage revision.

13.0 For Executives/Non-unionized Supervisors separated on or after 01.01.2007: All Executives/Non-unionized Supervisors who were on the rolls of the Company as on 01.01.2007 but subsequently ceased to be in the service on account of Superannuation, Resignation, Voluntary Retirement, Termination of employment, Death etc., would be eligible for benefits of the revised scales of pay up to the period they were in the employment of the Company.


14.0 All payments shall be subject to income tax as per Income Tax Act.

15.0 Other conditions: Merely because of revision of scales of pay, there will not be any upward revision in the various allowances and benefits/perks related to scale /pay. Suitable modifications in the entitlement will be made separately in the relevant rules regarding TA, LTC etc, taking into account the revised scales of pay.

Wherever, recovery is to be made on account of revision of scales of pay, the same will be effected from the arrears/monthly salaries.

Arrears on account of revision of scales of pay, payable from 01.01.2007 after adjusting adhoc advance paid earlier and other statutory recoveries etc., will be shortly credited to the respective Bank Account of the eligible employees.

This issues with the approval of Competent Authority.
