**KIOCL REPORTS ALL TIME HIGHEST REVENUE**

The Board of KIOCL Limited, a CPSU under Ministry of Steel, approved the Financial Results for the 4th quarter and for the financial year 2019-20 on 25.06.2020. The Turnover, production, Despatches reached all-time high. Company also received all statutory clearances from GOI for backward and forward integration projects of Blast Furnace.

The highlights of performance are summarized as under:

**Key highlights - FY 2019-20**

- Pellet Production 2.375 Million Ton as against 2.238 million tons of previous FY, up by 6%
- Dispatches 2.356 Million Tons as against 2.206 million tons of previous FY, up by 7%.
- Total revenue Rs.2056.53 Crores, as against Rs.2012.68 crores of previous FY, up by 2%
- Production and Despatches are high since 2006 and the Turnover is high since inception of Company
- Profit before Tax Rs. 63.68Crores, Profit after Tax Rs. 43.48 Crores
- Export of Pellet 1.99 Million Ton, **Highest since closure of captive mine (end of 2005) at Kudremukh.**

Shri MV Subba Rao, CMD, KIOCL informed that export market has helped to improve performance of the Company. Total exports stood at 84% and the pellets were exported to Brazil, Middle East, China, Europe etc. For inward and outward movement of materials utilized 100% Coastal route.

**New Business and Projects**

KIOCL has entered into Exploration of Minerals activities and received orders worth of Rs.105 Crores from GoI and GoK which are under active execution stage. Forward and Backward Integration of BFU projects are under tender stage. Statutory clearances for notified captive Iron ore mine is still under process. NIT for all tenders preparing as per guidelines of Atmanirbhar Bharat.

**Dividend**

The Board of Directors have recommended a dividend of Rs 0.70 per equity share, subject to the approval of the shareholders at the Annual General Meeting. The total dividend for the financial year ended 31<sup>st</sup> March, 2020 amounts to Rs. 43.54 Crores, thereby distributing dividend as 100% of PAT.
