Brief Profile of Shri T. Saminathan is as under:

Sri T. Saminathan holds Degree in Mechanical Engineering and Post Graduate Diploma in Business Management and has more than three decades of experience in KIOCL Limited in the iron ore Mining, Beneficiation, Pelletization and Pig iron making since joining in the year 1986 as Graduate Engineer.

During initial period, he served in Kudremukh mine Beneficiation Plant and later moved to Corporate Office, Technical Services Department, Bangalore in 1992 and executed projects viz: Crusher III installation, Relocation of Crusher I and installation of additional Ball Mills. He also served in CMD's Secretariat as Technical Officer to CMD for a shorter period and moved on to materials department in the year 2009.

Prior to assuming the charge of Chairman-cum-Managing Director he was holding the post of Director (Commercial) and prior to that he served as GM (Materials) heading both the Materials & Commercial Divisions.

He was instrumental in bringing tolling concept which had resulted in increased Capacity utilization of Pellet Plant, improved physical & financial performance of the Company. He also put in place system improvement in supply chain and logistics which had resulted in reduced transit and brought down inventory holding level.
